**PORT TERMINAL MANAGEMENT CONTRACT FOR PORT OF OPOL, MISAMIS
ORIENTAL**

BAC-PTMC-01-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the PTMC for Port of Opol in newspaper of general circulation, PPA website and in conspicuous places in the PPA premises on 07 September 2023;

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 447,793,436.34;

WHEREAS, in response to the said advertisement, the Joint Venture of Globalport Terminals, Inc. and Globalport Ozamiz Terminal, Inc. (JV GTI/GOTI) and Oroport Cargohandling Services, Inc., (OCSI) secured the Bid Documents in the amount of Php 100,000.00;

WHEREAS, during the Opening of Bids on 29 September 2023 at 10:00 a.m., OCSI was declared as automatically “disqualified” on the ground that their Technical Proposal was not book-bound as prescribed under the Instructions to Bidders;

WHEREAS, the JV GTI/GOTI was declared “passed” with the requirements of the First Envelope;

WHEREAS, the Second Envelope of the JV GTI/GOTI was opened and its Proposed Concession Fee was read as follows:

WHEREAS, Bid Evaluation was conducted to determine compliance with the requirements of PPA Administrative Order (AO) No. 12-2018; and the Bid Evaluation Report was approved by the BAC-PTMC on 2 October 2023, declaring the JV GTI/GOTI at its Proposed Concession Fee of Five Hundred Fifty-Five Million Pesos

(Php 555,000,000.00) exclusive of all taxes as the Bidder with the Highest Concession Fee;

WHEREAS, Post-Qualification was conducted on 06 October 2023 to determine compliance with all the requirements, terms and conditions for eligibility and the bidding; and in the Post-Qualification Report, as approved by the BAC-PTMC on 20 October 2023, the proposal of the JV GTI/GOTI was declared as the Highest Responsive Bid;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-PTMC hereby RESOLVE, as it is hereby RESOLVED, to declare the JV GTI/GOTI at its Proposed Concession Fee of Five Hundred Fifty-Five Million Pesos (Php 555,000,000.00) exclusive of all taxes, as the Highest Responsive Bidder and to recommend the award of Port Terminal Management Contract for Port of Opol.
