Award of Contract for the  
**CONSULTANCY SERVICES FOR THE CONDUCT OF FEASIBILITY  
STUDIES AND FORMULATION OF MASTER PLANS AT SELECTED PORTS**

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Conduct of Feasibility Studies and Formulation of Master Plans at Selected Ports, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 12 September 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 26,144,804.70**;

WHEREAS, in response thereto, five (5) consulting firms secured the Eligibility Documents, namely:

1. Science & Vision for Technology, Incorporated
2. Syconsult, Incorporated
3. Sycip Gorres Velayo and Company
4. CPRM Consultants, Incorporated
5. AMH Philippines, Incorporated

WHEREAS, only the joint venture of Science & Vision for Technology, Inc. and Syconsult, Inc. submitted its Eligibility Documents within the prescribed deadline for submission thereof while the three (3) prospective bidders, namely: Sycip Gorres Velayo and Company; CPRM Consultants, Inc. and AMH Philippines, Inc. did not submit their duly accomplished Eligibility Documents;

WHEREAS, after the Eligibility Screening conducted on 20 September 2019, Science & Vision for Technology, Inc./Syconsult, Inc./JV was declared eligible to bid for the project;

WHEREAS during the opening of the Technical Proposals (First Envelope) conducted on 17 October 2019, Science & Vision for Technology, Inc./Syconsult, Inc./JV passed the requirements of the First Envelope;

WHEREAS, the Technical Proposal of Science & Vision for Technology, Inc./Syconsult, Inc./JV was evaluated using the approved criteria for evaluation to determine its rating, as follows:

1. Experience and Capabilities of Firm	-	15%
2. Plan of Approach and Methodology	-	25%
3. Quality of Personnel	-	60%
<b>Total</b>		<b>100%</b>

and after due deliberation by the BAC, Science & Vision for Technology, Inc./Syconsult, Inc./JV was declared as "passed;"

WHEREAS, the Financial Proposal of Science & Vision for Technology, Inc./Syconsult, Inc./JV was opened on 22 October 2019 and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson;

WHEREAS, Bid Evaluation was conducted on 24 October 2019 to determine arithmetical or computational errors on the bid proposal of Science & Vision for Technology, Inc./Syconsult, Inc./JV and the Bid Evaluation Report, which was approved by the BAC on 25 October 2019, showed discrepancies on the bid proposal of Science & Vision for Technology, Inc./Syconsult, Inc./JV;

WHEREAS, Science & Vision for Technology, Inc./Syconsult, Inc./JV was declared as the Single Rated Bidder in the amount of ₱ 26,043.800.00, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;


WHEREAS, Post-qualification was conducted on 28 October 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Science & Vision for Technology, Inc./Syconsult, Inc./JV and in the Post-Qualification Report, approved by the BAC on 30 October 2019, Science & Vision for Technology, Inc./Syconsult, Inc./JV was declared as the Single Rated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE, as it is hereby RESOLVED, to declare **SCIENCE & VISION FOR TECHNOLOGY, INCORPORATED/SYCONSULT, INCORPORATED/JOINT VENTURE** as the Single Rated and Responsive Bidder and to recommend the award of contract for the Consultancy Services for the Conduct of Feasibility Studies and Formulation of Master Plans at Selected Ports, in the amount of **TWENTY SIX MILLION FORTY THREE THOUSAND EIGHT HUNDRED PESOS (₱ 26,043.800.00)**, inclusive of taxes, to the said bidder.


