Award of Contract for the SAN ANDRES PORT EXPANSION PROJECT, PORT OF SAN ANDRES, QUEZON

LFP MRQ NO. 023-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the San Andres Port Expansion Project, Port of San Andres, Quezon, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 09 July 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 183,250,222.31**;

WHEREAS, in response to the said advertisement, eight (8) bidders secured the Bid Documents in the amount of ₱ 50,000.00;

WHEREAS, only seven (7) bidders dropped their Technical and Financial Proposals before the prescribed deadline for submission. RCDG Construction Corporation submitted its letter of withdrawal from participating in the bidding before the opening of bids while E. M. Cuerpo Inc./Syndtite Construction Corp./JV did not submit its Technical and Financial Proposals nor submitted a letter of withdrawal from participating in the bidding before the prescribed deadline for submission of bid documents:

WHEREAS, during the opening of bids on 03 August 2021 at 10:00 a.m., the six (6) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the six (6) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 10 August 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 11 August 2021, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Sunwest Construction and Development Corp., F. Gurrea Construction Inc. and Hi-Tone Construction and Development Corp.;

WHEREAS, RCE Global Construction Inc. was declared as the Lowest Calculated Bidder in the amount of ₱ 176,538,323.78;

WHEREAS, due to travel restrictions brought about by the COVID-19 pandemic, post-qualification was conducted on 13 & 31 August 2021 and 06 September 2021 to examine, validate, and verify the eligibility, technical and financial requirements submitted by RCE Global Construction Inc. and in the Post-Qualification Report, as approved by the BAC on 07 October 2021, RCE Global Construction Inc. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare RCE GLOBAL CONSTRUCTION INC. as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the San Andres Port Expansion Project, Port of San Andres, Quezon, in the amount of ONE HUNDRED SEVENTY SIX MILLION FIVE HUNDRED THIRTY EIGHT THOUSAND THREE HUNDRED TWENTY THREE PESOS AND 78/100 (P 176,538,323.78), inclusive of taxes, to the said bidder.
