Award of Contract for the

CONSTRUCTION OF WHARF AND PORT OPERATIONAL AREA WITH CONTINUOUS RORO RAMP, PORT OF CATAGBACAN, LOON, BOHOL

LFP BHL NO. 032-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Wharf and Port Operational Area with Continuous RoRo Ramp, Port of Catagbacan, Loon, Bohol, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 29 September 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 669,307,773.87**;

WHEREAS, in response to the said advertisement, six (6) bidders secured the Bid Documents in the amount of **?** 75,000.00 and submitted their Technical and Financial Proposals, namely:

- 1. HG-III Construction and Development Corporation
- 2. F.Gurrea Construction Incorporated
- 3. Sunwest Construction and Development Corporation
- 4. Mamsar Construction and Industrial Corporation
- 5. WTG Construction and Development Corporation
- 6. MAC Builders

WHEREAS, during the opening of bids on 21 October 2021 at 10:00 a.m., only four (4) bidders were declared "passing" with the requirements of the First Envelope. WTG Construction and Development Corporation and HG-III Construction and Development Corporation were declared "failed" for failure to comply with the requirements of the First Envelope (Technical Component);

WHEREAS, WTG Construction and Development Corporation and HG-III Construction and Development Corporation signified no intention to file a request for reconsideration, hence they were notified that their unopened Second Envelope will be returned by the BAC;

WHEREAS, the Financial Proposals of the four (4) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 27 October 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 28 October 2021, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Mamsar Construction and Industrial Corp., Sunwest Construction and Development Corporation and F. Gurrea Construction Inc.;

WHEREAS, post-qualification was conducted on 03 to 05 & 09 November 2021 to examine, validate, and verify the eligibility, technical and financial requirements submitted by Mamsar Construction and Industrial Corp. and in the Post-Qualification Report, as approved by the BAC on 10 November 2021, Mamsar Construction and Industrial Corp. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare MAMSAR CONSTRUCTION AND INDUSTRIAL CORP.as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Wharf and Port Operational Area with Continuous RoRo Ramp, Port of Catagbacan, Loon, Bohol, in the amount of SIX HUNDRED SIXTY SIX MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND **PESOS** (₱ 666,988,000.00), inclusive of taxes, to the said bidder.
