**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
RESTORATION/IMPROVEMENT AND REPAINTING OF VTMS RADAR STATION 2
FACILITY AT CORREGIDOR ISLAND, CAVITE
HO-INFRA-PPDD-23-0055**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Restoration/Improvement and Repainting of VTMS Radar Station 2 Facility at Corregidor Island, Cavite, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Mania, on 17 October 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 1,353,759.62**;

WHEREAS, no bidder responded and secured the bid documents for the said project;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Restoration/Improvement and Repainting of VTMS Radar Station 2 Facility at Corregidor Island, Cavite, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

“35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Restoration/Improvement and Repainting of VTMS Radar Station 2 Facility at Corregidor Island, Cavite, be declared a “failure” pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that no bids are received.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, subject to the preparation of the Revised Program of Works (POW) by PMO – NCR North.

This has reference to the Opening of Bids for the Restoration of and Repainting of VTMS Control Center Facility at Manila International Container Terminal (MICT), Tondo, Manila, and Restoration/Improvement and Repainting of VTMS Radar Station 2 Facility at Corregidor Island, Cavite, held on 09 November 2023, at 9:00 a.m. and 11:00 a.m., respectively, which was both declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: "xxx xxx a) No bids are received. xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 044-2023 and 045-2023 Series of 2023, recommending that the bidding for the above projects be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, subject to the preparation of the Revised Program of Works (P0W) by PMO-NCR North, for consideration and approval of the General Manager as Head of the Procuring Entity.
