WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Maintenance Services for Enterprise Storage Array and Related Equipment, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 09 September 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 3,200,000.00**;

WHEREAS, in response to the said advertisement, only Infostorage Corporation secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 02 October 2020 at 2:00 p.m., Infostorage Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Infostorage Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 07 October 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 08 October 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Infostorage Corporation;

WHEREAS Infostorage Corporation was declared as the Single Calculated Bidder in the amount of ₱ 3,200,000.00;

WHEREAS, post-qualification was conducted on 12 October 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Infostorage Corporation and in the Post-Qualification Report, as approved by the BAC on 16 October 2020, Infostorage Corporation was declared as the Single Calculated and Responsive Bidder;


NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **INFOSTORAGE CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply and Delivery of Maintenance Services for Enterprise Storage Array and Related Equipment, in the amount of **THREE MILLION TWO HUNDRED THOUSAND PESOS (₱ 3,200,000.00)**, inclusive of taxes, to the said bidder.




