WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Fifteen (15) Units Manlift, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 05 October 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 225,000,000.00**;

WHEREAS, in response to the said advertisement, only BT Industries Incorporated secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 28 October 2020 at 10:00 a.m., BT Industries Incorporated was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of BT Industries Incorporated was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 30 October 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 03 November 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of BT Industries Incorporated;

WHEREAS BT Industries Incorporated was declared as the Single Calculated Bidder in the amount of ₱ 224,550,000.00;

WHEREAS, post-qualification was conducted on 06 November 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by BT Industries Incorporated and in the Post-Qualification Report, as approved by the BAC on 10 November 2020, BT Industries Incorporated was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BT INDUSTRIES INCORPORATED** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply and Delivery of Fifteen (15) Units Manlift, in the amount of **TWO HUNDRED TWENTY FOUR MILLION FIVE HUNDRED FIFTY THOUSAND PESOS (₱ 224,550,000.00)**, inclusive of taxes, to the said bidder.
