Award of Contract for the
PROVISION AND DELIVERY OF CY 2023 PPA OFFICIAL UNIFORMS
ASD-142-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Provision and Delivery of CY 2023 PPA Official Uniforms, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 29 September 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 5,596,200.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 10,000.00 and submitted their Technical and Financial Proposals, namely;

1. Dels Apparel Corporation
2. Dante's Executive Menswear and Bag's Accessories

WHEREAS, during the opening of bids on 25 October 2023 at 10:00 a.m. only Dante's Executive Menswear and Bag's Accessories was declared "passing" with the requirements of the First Envelope, while Dels Apparel Corporation was declared "failed" for failure to comply with the Technical Specifications, for the following reasons:

- a. For the Polo Shirt
 - The fabric and collar of the submitted sample did not match the required fabric.
 - The embroidery of the Philippine Flag in the submitted sample is with white outline, which is not required under the Terms of Reference (TOR).
 - The DOTr logo's outer outline in the submitted sample is color white, which is not consistent with the prescribed Blue Pantone 588 under the TOR.
- b. For the Gala Uniform
 - The half left side of the globe, half right side of the globe and the sun with three rays are not evident in the submitted sample.

WHEREAS, Dels Apparel Corporation signified its intention to file a request for reconsideration on its "failed" rating, hence, the unopened Second Envelope was retained by the BAC, until the request for reconsideration has been resolved by the Committee;

WHEREAS, the Financial Proposal of Dante's Executive Menswear and Bag's Accessories was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Dels Apparel Corporation did not file a request for reconsideration within the prescribed deadline for filing thereof;

WHEREAS, Bid Evaluation was conducted on 26 October 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 27 October 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Dante's Executive Menswear and Bag's Accessories;

WHEREAS, Dante's Executive Menswear and Bag's Accessories was declared as the Single Calculated Bidder in the amount of ₱ 5,596,200.00;

WHEREAS, post-qualification was conducted on 08 November 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Dante's Executive Menswear and Bag's Accessories and in the Post-Qualification Report, as approved by the BAC on 10 November 2023, Dante's Executive Menswear and Bag's Accessories was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **DANTE'S EXECUTIVE MENSWEAR AND BAG'S ACCESSORIES** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Provision and Delivery of CY 2023 PPA Official Uniforms, in the amount of **FIVE MILLION FIVE HUNDRED NINETY SIX THOUSAND TWO HUNDRED PESOS (PHP 5,596,200.00)**, inclusive of taxes, to the said bidder.
