SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF CCTV SURVEILLANCE MONITORING FOR NEW SITES FOR PMOS ASD-140-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Commissioning of CCTV Surveillance Monitoring for New Sites for PMOs, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 03 October 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 330,000,000.00**;

WHEREAS, in response to the said advertisement, only Kit Properties, Inc./Beyondsight Philippines, Inc./iPointeast Inc./JV secured the Bid Document in the amount of **₱ 50,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 25 October 2023 at 2:00 p.m., Kit Properties, Inc./Beyondsight Philippines, Inc./iPointeast Inc./JV was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Kit Properties, Inc./Beyondsight Philippines, Inc./iPointeast Inc./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 26 October 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 27 October 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Kit Properties, Inc./Beyondsight Philippines, Inc./iPointeast Inc./JV;

WHEREAS, Kit Properties, Inc./Beyondsight Philippines, Inc./iPointeast Inc./JV was declared as the Single Calculated Bidder in the amount of **₱ 328,499,998.71**;

WHEREAS, post-qualification was conducted on 08 November 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Kit Properties, Inc./Beyondsight Philippines, Inc./iPointeast Inc./JV and in the Post-Qualification Report, as approved by the BAC on 10 November 2023, Kit Properties, Inc./Beyondsight Philippines, Inc./iPointeast Inc./JV was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **KIT PROPERTIES, INC./BEYONDSIGHT PHILIPPINES, INC./IPOINTEAST INC./JV** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery, Installation and Commissioning of CCTV Surveillance Monitoring for New Sites for PMOs, in the amount of **THREE HUNDRED TWENTY EIGHT MILLION FOUR HUNDRED NINETY NINE THOUSAND NINE HUNDRED NINETY EIGHT PESOS AND 71/100 (PHP 328,499,998.71)**, inclusive of taxes, to the said bidder.
