WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Information Technology (IT) Resources, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 28 September 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 48,361,750.00**;

WHEREAS, in response to the said advertisement, only Dalaz Enterprises secured the Bid Document in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 24 October 2023 at 10:00 a.m., Dalaz Enterprises was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Dalaz Enterprises was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:


