### **RESOLUTION DECLARING FAILURE OF BIDDING FOR THE ROAD PAVEMENT AND DRAINAGE REHABILITATION ALONG DELPAN-ISLA PUTING BATO (IPB) ROADWAY AT SLIP 0, NORTH HARBOR, TONDO, MANILA HO-INFRA-PPDD-23-0056**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Road Pavement and Drainage Rehabilitation along Delpa-Isla Puting Bato (IPB) Roadway at Slip 0, North Harbor, Tondo, Manila, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 17 October 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 14,101,095.33**;

WHEREAS, in response to the said advertisement, only Zaneya Builders & Supply secured the Bid Document in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 09 November 2023 at 2:00 p.m., Zaneya Builders & Supply was declared "failed" with the requirements of the First Envelope, for the following reasons;

- a. Failure to submit proof of capacity and ownership for the pledged one (1) unit Concrete Vibrator (5hp).
- b. Failure to submit proof of ownership for the pledged one (1) unit Oxygen/Acetylene Cutting Outfit and one (1) unit Bar Cutter (28mm). Only Delivery Receipt was submitted, which is not an acceptable as proof of ownership.

WHEREAS, Zaneya Builders & Supply signified its intention to file a request for reconsideration, hence, its unopened Second Envelope (Financial Proposal) was retained by the BAC, until the request for reconsideration has been resolved by the Committee;

WHEREAS, Zaneya Builders & Supply did not file its request for reconsideration within the prescribed deadline for filing thereof;

WHEREAS, considering that Zaneya Builders & Supply was declared "failed," the BAC, after a motion duly made and properly seconded, declared the bidding for the Road Pavement and Drainage Rehabilitation along Delpa-Isla Puting Bato (IPB) Roadway at Slip 0, North Harbor, Tondo, Manila, a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, to wit:

“35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx


b) All prospective bidders are declared ineligible;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Road Pavement and Drainage Rehabilitation along Delpan-Isla Puting Bato (IPB) Roadway at Slip 0, North Harbor, Tondo, Manila, be declared a “failure” pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that “all prospective bidders are declared ineligible.”
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
