WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Improvement of Back-Up Area, Port of Lubang, Occidental Mindoro, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 05 October 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 22,792,289.76**;

WHEREAS, in response to the said advertisement, only MRBII Construction Corporation secured the Bid Document in the amount of ₱ 25,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 26 October 2023 at 2:00 p.m., the lone bidder, MRBII Construction Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of MRBII Construction Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 31 October 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 07 November 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of MRBII Construction Corporation;

WHEREAS, MRBII Construction Corporation was declared as the Single Calculated Bidder in the amount of ₱ 22,674,975.57;

WHEREAS, post-qualification was conducted on 11 November 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by, MRBII Construction Corporation and in the Post-Qualification Report, as approved by the BAC on 13 November 2023, MRBII Construction Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, **MRBII CONSTRUCTION CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Improvement of Back-Up Area, Port of Lubang, Occidental Mindoro, in the amount of **TWENTY TWO MILLION SIX HUNDRED SEVENTY FOUR THOUSAND NINE HUNDRED SEVENTY FIVE PESOS AND 57/100 (₱ 22,674,975.57)**, inclusive of taxes, to the said bidder.
