WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Brgy. U-Og Port Development Project, Brgy. U-Og, Inabanga, Bohol (DOTr Project downloaded to PPA for implementation), in the Manila Standard, a newspaper of general nationwide circulation on 09 October 2018 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₱ 45,355,694.70**;

WHEREAS, in response to the said advertisement, only Khan Kon Chi Const. and Dev't. Corp. secured and submitted the Bid Documents in the amount of ₱ 25,000.00;

WHEREAS, during the opening of bids on 30 October 2018 at 2:00 p.m., Khan Kon Chi Const. and Dev't. Corp. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Khan Kon Chi Const. and Dev't. Corp. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 31 October 2018 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 05 November 2018, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Khan Kon Chi Const. and Dev't. Corp.;

WHEREAS, Khan Kon Chi Const. and Dev't. Corp. was declared as the Single Calculated Bidder in the amount of ₱ 44,578,616.78;

WHEREAS, post-qualification was conducted on 9-10 November 2018 to examine, validate and verify the eligibility, technical and financial requirements submitted by Khan Kon Chi Const. and Dev't. Corp. and in the Post-Qualification Report, as approved by the BAC on 15 November 2018, Khan Kon Chi Const. and Dev't. Corp. was declared as the Single Calculated and Responsive Bidder;


NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Brgy. U-Og Port Development Project, Brgy. U-Og, Inabanga, Bohol, in the amount of **FORTY FOUR MILLION FIVE HUNDRED SEVENTY EIGHT THOUSAND SIX HUNDRED SIXTEEN AND 78/100 PESOS (₱ 44,578,616.78)**, inclusive of taxes, to the said bidder.
