WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery and Installation of Air Conditioning Units for Port Management Offices (Phase IV), in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 26 September 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 80,000,000.00**;

WHEREAS, in response to the said advertisement, only Grun Tech Solutions Inc. secured the Bid Document in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 18 October 2023 at 10:00 a.m., Grun Tech Solutions Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Grun Tech Solutions Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 23 October 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 25 October 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Grun Tech Solutions Inc.:

WHEREAS, Grun Tech Solutions Inc. was declared as the Single Calculated Bidder in the amount of ₱ 79,994,901.40;

WHEREAS, post-qualification was conducted on 03 November 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Grun Tech Solutions Inc. and in the Post-Qualification Report, as approved by the BAC on 10 November 2023, Grun Tech Solutions Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **GRUN TECH SOLUTIONS INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery and Installation of Air Conditioning Units for Port Management Offices (Phase IV), in the amount of **SEVENTY NINE MILLION NINE HUNDRED NINETY FOUR THOUSAND NINE HUNDRED ONE PESOS AND 40/100 (PHP 79,994,901.40)**, inclusive of taxes, to the said bidder.
