WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Construction and Offshore Installation of Aids to Marine Navigation at Ports of Estancia, Iloilo; Culasi, Roxas City; and Dumanguit, New Washington, Aklan, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 08 October 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 328,684,412.27**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

1. Jarzoe Builders, Incorporated/Dalebo Construction & General Merchandise/Joint Venture
2. MAC Builders

WHEREAS, during the opening of bids on 29 October 2019 at 10:00 a.m., the two (2) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 05 November 2019 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 06 November 2019, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Jarzoe Builders, Inc./Dalebo Const. & General Merchandise/JV;

WHEREAS, despite said discrepancies, the ranking of the two (2) bidders were not affected, hence Jarzoe Builders, Inc./Dalebo Const. & General Merchandise/JV was declared as the Lowest Calculated Bidder in the amount of ₱ 328,013,357.76, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;


WHEREAS, post-qualification was conducted on 18 November 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Jarzoe Builders, Inc./Dalebo Const. & General Merchandise/JV and in the Post-Qualification Report, as approved by the BAC on 22 November 2019, Jarzoe Builders, Inc./Dalebo Const. & General Merchandise/JV was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **JARZOE BUILDERS, INCORPORATED/DALEBO CONSTRUCTION & GENERAL MERCHANDISE/ JOINT VENTURE** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Proposed Construction and Offshore Installation of Aids to Marine Navigation at Ports of Estancia, Iloilo; Culasi, Roxas City; and Dumanguit, New Washington, Aklan, in the amount of **THREE HUNDRED TWENTY EIGHT MILLION THIRTEEN THOUSAND THREE HUNDRED FIFTY SEVEN AND 76/100 PESOS (₱ 328,013,357.76)**, inclusive of taxes, to the said bidder.
