**PORT TERMINAL MANAGEMENT CONTRACT FOR PORT OF TABACO**  
BAC-PTMC-04-2020

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Port Terminal Management Contract for Port of Tabaco in the Manila Times, PPA website and in conspicuous places in the PPA premises on 14 December 2020;

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 351,873,350.42 exclusive of all taxes;

WHEREAS, in response to the said advertisement, one (1) bidder, Prudential Customs Brokerage Services, Inc., secured the Bid Documents in the amount of Php 150,000.00;

WHEREAS, during the Opening of Bids on 25 January 2021 at 10:00 a.m., Prudential Customs Brokerage Services, Inc. was declared "passed" in the requirements of the First Envelope;

WHEREAS, the Second Envelope of Prudential Customs Brokerage Services, Inc. was opened, with its Proposed Concession Fee read as follows:
