RESOLUTION DECLARING FAILURE OF BIDDING FOR THE IMPROVEMENT/RESTORATION OF RC PLATFORM, RORO RAMP NO. 1, BACK-UP AREA, RETAINING WALL, PASSENGER TERMINAL BUILDING, FENCE AND GATE, PORT OF PIO DURAN, ALBAY

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Improvement/Restoration of RC Platform, Roro Ramp No. 1, Back-Up Area, Retaining Wall, Passenger Terminal Building, Fence and Gate, Port of Pio Duran, Albay, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 26 October 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 31,761,982.72**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 25,000.00, namely:

- 1. Mancol Construction Corporation
- 2. Bemkar Construction and Supply

WHEREAS, Mancol Construction Corp. and Bemkar Construction and Supply submitted their letters of withdrawal from participating in the bidding, dated November 17, 2023 and November 20, 2023, respectively, before the prescribed deadline for submission thereof, and the BAC, finding the reasons to be meritorious, accepted their withdrawal from participating in the bidding;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Improvement/Restoration of RC Platform, Roro Ramp No. 1, Back-Up Area, Retaining Wall, Passenger Terminal Building, Fence and Gate, Port of Pio Duran, Albay, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

XXX XXX XXX."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- To recommend to the Head of the Procuring Entity that the bidding for the Improvement/Restoration of RC Platform, Roro Ramp No. 1, Back-Up Area, Retaining Wall, Passenger Terminal Building, Fence and Gate, Port of Pio Duran, Albay, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that no bids are received.
- 2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Opening of Bids for the Improvement/Restoration of RC Platform, RoRo Ramp No. 1, Back-up Area, Retaining Wall, Passenger Terminal Building, Fence and Gate, Port of Pio Duran, Albay, held on 21 November 2023, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: "xxx xxx a) No bids are received. xxx xxx."
