Award of Contract for the

UPGRADING OF FENDERING SYSTEM AT PIER 1 INCLUDING RESTORATION OF DAMAGED CURTAIN WALL, DRAINAGE SYSTEM AT BACK-UP AREA & PORT ROAD, PORT OF DUMAGUETE, DUMAGUETE CITY

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Upgrading of Fendering System at Pier 1 Including Restoration of Damaged Curtain Wall, Drainage System at Back-Up Area & Port Road, Port of Dumaguete, Dumaguete City, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 17 October 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 48,465,952.54**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 25,000.00 and submitted their Technical and Financial Proposals, namely:

- 1. Big J Steel Construction Corporation
- 2. A.S.T. Builders

WHEREAS, during the opening of bids on 10 November 2023 at 11:00 a.m., only A.S.T. Builders was declared "passing" with the requirements of the First Envelope. Big J Steel Construction Corporation was declared "failed" with the requirements of the Technical Proposal, for the following reasons:

- a. Failed to meet the required Experience Record for the Reinforcement Concrete Works and Installation of Fenders, what was submitted was 200.68 cu.m. for Reinforcement Concrete Works and 32 sets for Installation of Fenders, the requirements are 388 cu.m. and 48 sets, respectively.
- Failed to submit a valid renewed Department of Public Works and Highways (DPWH) Certification of Accreditation for the pledged Materials Engineer.

HO-BAC-EP Res. No. 051-2023 Page 1 of 3 c. The Certification of Availability of Equipment of the pledged one (1) unit Leased Pumpcrete was issued by the bidder and not the lessor. Likewise, the Contract of Lease for the said equipment was not duly notarized.

WHEREAS, Big J Steel Construction Corporation signified its intention to file a request for reconsideration, hence, the unopened Second Envelope was retained by the BAC, until the request for reconsideration have been resolved by the Committee;

WHEREAS, the Financial Proposal of A.S.T. Builders was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Big J Steel Construction Corporation did not file its request for reconsideration within the prescribed deadline for filing thereof;

WHEREAS, Bid Evaluation was conducted on 14 November 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 15 November 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of A.S.T. Builders;

WHEREAS, A.S.T. Builders was declared as the Single Calculated Bidder in the amount of ₱ 48,412,888.26;

WHEREAS, post-qualification was conducted on 17 & 18 November 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by A.S.T. Builders and in the Post-Qualification Report, as approved by the BAC on 24 November 2023, A.S.T. Builders was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **A.S.T. BUILDERS** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Upgrading of Fendering System at Pier 1 Including Restoration of Damaged Curtain Wall, Drainage System at Back-Up Area & Port Road, Port of Dumaguete, Dumaguete City, in the amount of **FORTY EIGHT MILLION FOUR HUNDRED TWELVE THOUSAND EIGHT HUNDRED EIGHTY EIGHT PESOS AND 26/100** (**P** 48,412,888.26), inclusive of taxes, to the said bidder.
