Award of Contract for the RESTORATION OF PORT FACILITIES, PORT OF LUCENA, LUCENA CITY AND PORTS OF CAWIT AND STA. CRUZ, MARINDUQUE HO-INFRA-PPDD-23-0068

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Restoration of Port Facilities, Port of Lucena, Lucena City and Ports of Cawit and Sta. Cruz, Marinduque, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 05 October 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 42,131,502.81**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 25,000.00 and submitted their Technical and Financial Proposals, namely:

- 1. Mancol Construction Corporation
- 2. Orientech Construction and Development Corporation

WHEREAS, during the opening of bids on 07 November 2023 at 9:00 a.m., only Mancol Construction Corporation was declared "passing" with the requirements of the First Envelope. Orientech Construction and Development Corporation was declared "failed" with the requirements of the Technical Proposal, for the following reasons:

- a. Failed to submit the Recapitulation or Final Bill of Quantities as a required supporting documents for the Statement of the Bidder's Single Largest Completed Contracts (SLCC) similar to the contract to be bid. The statement should be supported by a Notice of Award, Notice to Proceed, Contract, Project Owner's Certificate of Final Acceptance issued by the Owner and/or Constructors Performance Evaluation System (CPES) and Recapitulation or Final Bill of Quantities, as stated in the footnote of the bid form.
- b. Failed to submit form for the Statement of the Bidder's Experience on the Major Categories of Work of the SLCC including other completed contracts similar to the contract to be bid.

HO-BAC-EP Res. No. 050-2023 Page 1 of 3 WHEREAS, Orientech Construction and Development Corporation signified no intention to file a request for reconsideration on their "failed" rating, hence, its Second Envelope was returned unopened and duly received by their authorized representative;

WHEREAS, the Financial Proposal of Mancol Construction Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 10 November 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 13 November 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Mancol Construction Corporation;

WHEREAS, Mancol Construction Corporation was declared as the Single Calculated Bidder in the amount of ₱ 42,023,528.07;

WHEREAS, post-qualification was conducted on 11 & 18 November 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Mancol Construction Corporation and in the Post-Qualification Report, as approved by the BAC on 24 November 2023, Mancol Construction Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **MANCOL CONSTRUCTION CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Restoration of Port Facilities, Port of Lucena, Lucena City and Ports of Cawit and Sta. Cruz, Marinduque, in the amount of **FORTY TWO MILLION TWENTY THREE THOUSAND FIVE HUNDRED TWENTY EIGHT PESOS AND 07/100** (**P 42,023,528.07**), inclusive of taxes, to the said bidder.
