WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster-National Capital Region, Central and Northern Luzon Comprising PPA Head Office, Port Management Offices (PMOs) NCR-North, NCR-South, Bataan/Aurora and Northern Luzon and Terminal Management Offices (TMOs)/Ports under their Respective Jurisdiction, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 17 October 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 90,268,692.00**;

WHEREAS, in response to the said advertisement, only Lockheed Security and Investigation Agency, Inc. secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 08 November 2019 at 10:00 a.m., Lockheed Security and Investigation Agency, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Lockheed Security and Investigation Agency, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, post-qualification was conducted on 19 November 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Lockheed Security and Investigation Agency, Inc. and in the Post-Qualification Report, as approved by the BAC on 21 November 2019, Lockheed Security and Investigation Agency, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **LOCKHEED SECURITY AND INVESTIGATION AGENCY, INC.** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of Security Services for Philippine Ports Authority, Port Security Cluster-National Capital Region, Central and Northern Luzon Comprising PPA Head Office, Port Management Offices (PMOs) NCR-North, NCR-South, Bataan/Aurora and Northern Luzon and Terminal Management Offices (TMOs)/Ports under their Respective Jurisdiction, in the amount of **NINETY MILLION TWO HUNDRED FIFTY EIGHT THOUSAND THREE HUNDRED SIXTY FOUR AND 20/100 PESOS (₱ 90,258,364.20)**, inclusive of taxes, to the said bidder.
