Award of Contract

PORT TERMINAL MANAGEMENT CONTRACT FOR THE CLUSTERED PORTS OF JAGNA, TAPAL, UBAY, TALIBON AND GETAFE, PROVINCE OF BOHOL BAC-PTMC-03-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the PTMC for the Clustered Ports of Jagna, Tapal, Ubay, Talibon and Getafe, Province of Bohol, in a newspaper of general circulation, PPA website and in conspicuous places in the PPA premises on 12 October 2023;

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 929,573,066.53;

WHEREAS, in response to the said advertisement, Animas Bros Arrastre Stevedoring Services, Inc. (ABASSI) and the Joint Venture of ABASSI and Tarsier Arrastre Stevedoring Services, Inc. (JV ABASSI/TASSI) secured the Bid Documents in the amount of Php 150,000.00;

WHEREAS, only the JV ABASSI/TASSI submitted its bid during the Deadline for Submission of Bids on 15 November 2023 at 9:00 a.m.;

WHEREAS, during the Opening of Bids on 15 November 2023 at 10:00 a.m., the JV ABASSI/TASSI was declared "passed" with the requirements of the First Envelope;

WHEREAS, the Second Envelope of the JV ABASSI/TASSI was opened and its Proposed Concession Fee was read as follows:

WHEREAS, Bid Evaluation was conducted to determine compliance with the requirements of PPA Administrative Order (AO) No. 12-2018; and the Bid Evaluation Report was approved by the BAC-PTMC on 17 November 2023, declaring the JV

ABASSI/TASSI at its Proposed Concession Fee of Nine Hundred Sixty-Seven Million Five Hundred Five Thousand Twelve Pesos (Php 967,505,012.00) exclusive of all taxes as the Bidder with the Highest Concession Fee;

WHEREAS, Post-Qualification was conducted on 23 November 2023 to determine compliance with all the requirements, terms and conditions for eligibility and the bidding; and in the Post-Qualification Report, as approved by the BAC-PTMC on 1 December 2023, the proposal of the JV ABASSI/TASSI was declared as the Highest Responsive Bid;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-PTMC hereby RESOLVE, as it is hereby RESOLVED, to declare the JV ABASSI/TASSI at its Proposed Concession Fee of Nine Hundred Sixty-Seven Million Five Hundred Five Thousand Twelve Pesos (Php 967,505,012.00) exclusive of all taxes, as the Highest Responsive Bidder and to recommend the award of Port Terminal Management Contract for Clustered Ports of Jagna, Tapal, Ubay, Talibon and Getafe, Province of Bohol.
