Award of Contract for the  
**PROCUREMENT OF FIREARMS FOR PORT POLICE**  
BAC-PGCS-006-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Firearms for Port Police, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 28 October 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 42,880,000.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of ₱ 25,000.00, namely:

1. Trust Trade
2. United Defense Manufacturing Corporation (UDMC)

WHEREAS, during the opening of bids on 21 November 2019 at 10:00 a.m., Trust Trade was declared "passing" with the requirements of the First Envelope. Unified Defense Manufacturing Corp. was automatically disqualified for failure to comply with the bid submission required under Section 20.3 of the Bid Date Sheet of the Bidding Documents which states that "All bid documents shall be book bound, hard bound and properly labelled with index tabs. xxx" The Technical Proposal of Unified Defense Manufacturing Corp. was not properly labeled;

WHEREAS, the Financial Proposal of Trust Trade was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 25 November 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 26 November 2019, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Trust Trade;

WHEREAS, Trust Trade was declared as the Single Calculated Bidder in the amount of ₱ 34,628,330.00;

WHEREAS, post-qualification was conducted on 28 November 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Trust Trade and in the Post-Qualification Report, as approved by the BAC on 04 December 2019, Trust Trade was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **TRUST TRADE** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement of Firearms for Port Police, in the amount of **THIRTY FOUR MILLION SIX HUNDRED TWENTY EIGHT THOUSAND THREE HUNDRED THIRTY PESOS (₱ 34,628,330.00)**, inclusive of taxes, to the said bidder.
