Award of Contract for the
**EXPANSION OF BACK-UP AREA WITH RORO RAMP, PORT OF LIPATA,
 SURIGAO CITY, SURIGAO DEL NORTE**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Expansion of Back-Up Area with RoRo Ramp, Port of Lipata, Surigao City, Surigao del Norte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 08 October 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 267,839,136.26**;

WHEREAS, in response to the said advertisement, eight (8) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

1. MRBII Construction Corporation
2. Equi-Parco Construction Company
3. Marra Builders, Incorporated
4. Luck-well Construction
5. Premium Megastructures, Incorporated
6. UKC Builders, Incorporated
7. Grace Construction Corporation
8. F. Gurrea Construction, Incorporated

WHEREAS, during the opening of bids on 05 November 2019 at 10:00 a.m., the eight (8) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of the eight (8) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 11 November 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 12 November 2019, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Grace Const. Corp.; UKC Builders, Inc. and MRBII Const. Corp.;

However, the submitted detailed estimate of F. Gurrea Const., Inc. and Luck-well Const. did not indicate the details of construction materials, number of personnel and required equipment. Thus, the bid proposals of F. Gurrea Const., Inc. and Luck-well Const. are considered non-responsive and automatically disqualified.

WHEREAS, the ranking of the bidders were affected, as shown in the Table below. Equi-Parco Const. Co. was declared as the Lowest Calculated Bidder in the amount of ₱ 253,030,720.00;

WHEREAS, post-qualification was conducted on 20 November 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by Equi-Parco Const. Co. and in the Post-Qualification Report, as approved by the BAC on 27 November 2019, Equi-Parco Const. Co. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **EQUI-PARCO CONSTRUCTION COMPANY** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Expansion of Back-Up Area with RoRo Ramp, Port of Lipata, Surigao City, Surigao del Norte, in the amount of **TWO HUNDRED FIFTY THREE MILLION THIRTY THOUSAND SEVEN HUNDRED TWENTY PESOS (₱ 253,030,720.00)**, inclusive of taxes, to the said bidder.
