FOR THE COVID 19 TESTING SERVICE FOR SEAFARERS

WHEREAS, the Administrative Services Department, as End-user unit, pursuant to Republic Act No. 11494 otherwise known as the Bayanihan to Recover as One Act, GPPB Resolution No. 18-2020 Approving the Rules on the Conduct of Procurement Activities Under Republic Act No. 11494 or the Bayanihan to Recover as One Act and the relevant procedures and requirements under GPPB Circular No. 01-2020 dated 06 April 2020, and as exemption from the provisions on bidding process required under Republic Act No. 9184 or the "Government Procurement Reform Act," resorted to Negotiated Procurement (Emergency Cases) for the conduct of Covid 19 Testing Service for Seafarers, in the most judicious, economical and expeditious manner;

WHEREAS, the End-user unit recommended to the Head of the Procuring Entity (HOPE) the revision of the Annual Procurement Plan (APP) for Goods and Consultancy Services, to reflect the Emergency Procurement under the Bayanihan to Recover As One Act and to post the APP in the PPA website and in the GPPB Online Portal;

WHEREAS, the Approved Budget for the Contract (ABC) is **₱ 270,000,000.00**;

WHEREAS, the End-user unit negotiated with FIRSTAIDE DIAGNOSTICS LABORATORY (FIRSTAIDE) for the provision of Covid 19 Testing Services for 79,202 Seafarers, in accordance with the Scope of Work/Test indicated in the Terms of Reference, as it has the technical, legal and financial capability to conduct the Testing Services;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend, for approval of the Head of the Procuring Entity, the award of contract for the Covid 19 Testing Service for Seafarers to **FIRSTAIDE DIAGNOSTICS LABORATORY (FIRSTAIDE)**, in the amount of **TWO HUNDRED SEVENTY MILLION PESOS (P270,000,000.00)**.
