Award of Contract for the
**CONSULTANCY SERVICES FOR THE INVENTORY AND STRUCTURAL
INVESTIGATION SURVEY OF ALL MARINE STRUCTURES AND ITS
ACCESSORIES AT SELECTED PORTS NATIONWIDE
(PACKAGE 1)**

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Inventory and Structural Investigation Survey of all Marine Structures and its Accessories at Selected Ports Nationwide (Package 1), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 19 April 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 33,140,863.46**;

WHEREAS, in response thereto, six (6) consulting firms secured the Eligibility Documents, namely:

1. Science & Vision for Technology, Inc.
2. Testlab Engineering & Geotech Services
3. E. H. Sison Engineers, Co.
4. Digiscript Philippines Inc.
5. Enrique O. Olonan and Associates
6. Harbor Star Shipping Services Inc.

WHEREAS, Science & Vision for Technology, Inc. and Testlab Engineering & Geotech Services submitted their eligibility documents as a Joint Venture; E. H. Sison Engineers, Co. and Digiscript Philippines Inc. submitted their respective Eligibility Documents as individual firms, while Enrique O. Olonan and Associates and Harbor Star Shipping Services Inc. did not submit their duly accomplished Eligibility Documents;

WHEREAS, after the Eligibility Screening conducted on 29 April 2021, Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV was declared eligible to bid for the project. E.H. Sison Engineers, Co. was declared ineligible while Digiscript Philippines, Inc. was automatically disqualified for submitting their eligibility documents which are not hard bound/book bound;

WHEREAS, E.H. Sison Engineers, Co. signified its intention to file a request for reconsideration on their ineligible rating however, on 30 April 2021, its representative informed the BAC verbally that they will no longer file their request for reconsideration;

WHEREAS during the opening of the Technical Proposals (First Envelope) conducted on 01 June 2021, Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV passed the requirements of the First Envelope;

WHEREAS, the Technical Proposal of Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV was evaluated using the approved criteria for evaluation to determine its rating, as follows:

1. Experience and Capabilities of Firm	-	15%
2. Plan of Approach and Methodology	-	25%
3. Quality of Personnel	-	60%
Total		100%

and after due deliberation by the BAC, Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV was declared as "passed;"

WHEREAS, the Financial Proposal of Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV was opened on 10 June 2021 and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson;

WHEREAS, after evaluation of the financial bid and calculation of the final scores, taking into consideration the technical and financial ratings, the following rating was arrived at;

WHEREAS, Bid Evaluation was conducted on 17 June 2021 to determine arithmetical or computational errors on the bid proposal of Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV and the Bid Evaluation Report, which was approved by the BAC on 18 June 2021, showed no discrepancies on the bid proposal of Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV;

WHEREAS, Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV was declared as the Single Rated Bidder in the amount of ₱ 33,116,020.00, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, Post-qualification was conducted on 21 June 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV and in the Post-Qualification Report, approved by the BAC on 23 June 2021, Science & Vision for Technology, Inc./Testlab Engineering & Geotech Services /JV was declared as the Single Rated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE, as it is hereby RESOLVED, to declare **SCIENCE & VISION FOR TECHNOLOGY, INC./TESTLAB ENGINEERING & GEOTECH SERVICES/JV** as the Single Rated and Responsive Bidder and to recommend the award of contract for the Consultancy Services for the Inventory and Structural Investigation Survey of all Marine Structures and its Accessories at Selected Ports Nationwide (Package 1), in the amount of **THIRTY THREE MILLION ONE HUNDRED SIXTEEN THOUSAND TWENTY PESOS (₱ 33,116,020.00)**, inclusive of taxes, to the said bidder.
