WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Ambulong Port Expansion Project, Port of Ambulong, Magdiwang, Romblon, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 October 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 166,483,539.26**;

WHEREAS, in response to the said advertisement, five (5) bidders secured the Bid Documents in the amount of \$\mathbb{P}\$ 50,000.00, namely:

- 1. MRBII Construction Corporation
- 2. Hi-Tone Construction and Development Corporation
- 3. Sunwest Construction and Development Corporation
- 4. F. Gurrea Construction Inc.
- 5. WTG Construction and Development Corporation

WHEREAS, during the opening of bids on 10 November 2021 at 2:00 p.m., the five (5) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the five (5) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 15 November 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 16 November 2021, showed discrepancies between the Total Bid Prices and Unit Bid Prices of MRBII Construction Corporation, Sunwest Construction and Development Corp., F. Gurrea Construction Inc. and WTG Construction and Development Corp., as follows:

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare MRBII CONSTRUCTION CORPORATION as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Ambulong Port Expansion Project, Port of Ambulong, Magdiwang, Romblon, in the amount of ONE HUNDRED SIXTY FOUR MILLION EIGHT HUNDRED THOUSAND PESOS AND 83/100(₱ 164,800,000.83), inclusive of taxes, to the said bidder.
