**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PORT TERMINAL
MANAGEMENT CONTRACT FOR THE CLUSTERED PORTS OF BALINGOAN
AND JASAAN**
BAC-PTMC-05-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Port Terminal Management Contract (PTMC) for the Clustered Ports of Balingoan and Jasaan in The Manila Times, PPA website and in conspicuous places in the PPA premises on 09 November 2023;

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 328,661,503.27, exclusive of all taxes;

WHEREAS, in response to the said advertisement, PCBSI Port Terminal Management Corp. (PCBSI PTMC) secured the Bid Documents in the amount of Php 100,000.00;

WHEREAS, PCBSI PTMC did not drop its technical and financial bid nor did it submit a Letter of Non-Participation before the deadline for submission of bids on 04 December 2023 at 9:00 a.m.;

WHEREAS, considering that no bidder dropped its technical and financial bid before the deadline for submission of bids, the BAC-PTMC, after a motion duly made and properly seconded, declared the bidding for the Port Terminal Management Contract for the Clustered Ports of Balingoan and Jasaan a failure pursuant to Section 24 (a) of the Guidelines for the Selection and Award of Contracts Under the Port Terminal Management Regulatory Framework (PPA AO No. 12-2018), which provides to wit:

“Section 24. Failure of Bidding

The BAC shall declare the bidding a failure and conduct a rebidding with re-advertisement and/or posting, after a re-evaluation of the terms, conditions, and specifications of the first bidding, when:

- a. No eligibility and/or bid proposals are received.

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-PTMC hereby RESOLVE, as it is hereby RESOLVED, to recommend the following:

1. Recommend to the General Manager as Approving Authority, that the bidding for the Port Terminal Management Contract for the Clustered Ports of Balingoan and Jasaan, be declared a "failure" pursuant to Section 24 (a) of PPA AO No. 12-2018;
2. Direct the BAC-PTMC to conduct a mandatory review and evaluation of the terms and conditions in the Bid Documents; and
3. Conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 24 of PPA AO No. 12-2018.
