**Award of Contract for the
MRRP-PORT FACILITIES (CIVIL WORKS), PORT OF MARAWI (MAA-SECTOR 8),
MARAWI CITY, LANA DEL SUR
PPA-TFBM NO. 001-2021**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the MMRP-Port Facilities (Civil Works), Port of Marawi (MAA-Sector 8), Marawi City, Lanao Del Sur, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 14 May 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 242,750,191.04**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of **₱ 50,000.00**, namely:

1. Mamsar Construction and Industrial Corporation
2. Premium Megastructures Inc.
3. Sunwest Construction and Development Corporation

WHEREAS, during the opening of bids on 08 June 2021 at 10:00 a.m., the three (3) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 14 June 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 15 June 2021, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Mamsar Construction and Industrial Corporation;

WHEREAS, Sunwest Construction and Development Corporation was declared "automatically disqualified," pursuant to Section 32.2.1a of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"Completeness of bid. xxx, bids not addressing or providing all of the required items in the Bidding Documents including, where applicable, bill of quantities, shall be considered non-responsive and, thus, automatically disqualified xxx."

WHEREAS, Mamsar Construction and Industrial Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 241,688,024.12;

WHEREAS, post-qualification was conducted on 28 June 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Mamsar Construction and Industrial Corporation and in the Post-Qualification Report, as approved by the BAC on 30 June 2021, Mamsar Construction and Industrial Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **MAMSAR CONSTRUCTION AND INDUSTRIAL CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the MMRP-Port Facilities (Civil Works), Port of Marawi (MAA-Sector 8), Marawi City, Lanao Del Sur, in the amount of **TWO HUNDRED FORTY ONE MILLION SIX HUNDRED EIGHTY EIGHT THOUSAND TWENTY FOUR PESOS AND 12/100 (₱ 241,688,024.12)**, inclusive of taxes, to the said bidder.
