WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Four (4) Units Bus, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 29 October 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 40,000,000.00**;

WHEREAS, in response to the said advertisement, only Lionsjade Corporation secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 24 November 2020 at 10:00 a.m., Lionsjade Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Lionsjade Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 27 November 2020 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 01 December 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Lionsjade Corporation;

WHEREAS Lionsjade Corporation was declared as the Single Calculated Bidder in the amount of ₱ 39,000,000.00;


