WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Renovation of Corporate Communications Staff Office, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 03 November 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 3,821,823.82;

WHEREAS, in response to the said advertisement, only Cytracon Corporation secured the Bid Document in the amount of ₱ 5,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 25 November 2021 at 10:00 a.m., Cytracon Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Cytracon Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 01 December 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 02 December 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Cytracon Corporation;

WHEREAS, Cytracon Corporation was declared as the Single Calculated Bidder in the amount of ₱ 3,789,848.04;

WHEREAS, post-qualification was conducted on 03 December 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Cytracon Corporation and in the Post-Qualification Report, as approved by the BAC on 10 December 2021, Cytracon Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **CYTRACON CORPORATION** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Renovation of Corporate Communications Staff Office, in the amount of **THREE MILLION SEVEN HUNDRED EIGHTY NINE THOUSAND EIGHT HUNDRED FORTY EIGHT PESOS AND 04/100 (PHP 3,789,848.04)**, inclusive of taxes, to the said bidder.


