WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Motor Vehicles for Port Management Offices (PMOs), in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 27 October 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **76,250,000.00**;

WHEREAS, in response to the said advertisement, only Toyota Alabang, Inc. secured the Bid Document in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 20 November 2023 at 2:00 p.m., Toyota Alabang, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Toyota Alabang, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 21 November 2023 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 28 November 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Toyota Alabang, Inc.;

WHEREAS, Toyota Alabang, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 76,202,500.00;

WHEREAS, post-qualification was conducted on 04 December 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Mode Matrix Manila, Inc. and in the Post-Qualification Report, as approved by the BAC on 06 December 2023, Toyota Alabang, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **TOYOTA ALABANG, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply and Delivery of Motor Vehicles for Port Management Offices (PMOs), in the amount of **SEVENTY SIX MILLION TWO HUNDRED TWO THOUSAND FIVE HUNDRED PESOS (PHP 76,202,500.00)**, inclusive of taxes, to the said bidder.
