Award of Contract for the
**PUERTO GALERA PORT EXPANSION PROJECT,
PORT OF PUERTO GALERA, ORIENTAL MINDORO**
LFP MDO NO. 026-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Puerto Galera Port Expansion Project, Port of Puerto Galera, Oriental Mindoro, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 October 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 149,509,773.48**;

WHEREAS, in response to the said advertisement, five (5) bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

1. Sunwest Construction and Development Corporation
2. Great Swiss Metal Builders Corporation
3. Khan Kon Chi Construction and Development Corporation
4. WTG construction and Development Corporation
5. MRBII Construction Corporation

WHEREAS, only four (4) bidders dropped their Technical and Financial Proposals on the scheduled date of the opening of bids. MRBII Construction Corporation submitted its letter of withdrawal dated 08 November 2021 from participating in the bidding, and the BAC, finding the reasons to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 10 November 2021 at 10:00 a.m., the four (4) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the four (4) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 15 November 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 16 November 2021, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Sunwest Construction and Development Corp. and WTG Construction and Development Corp., as follows:

WHEREAS, Great Swiss Metal Builders Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 147,623,885.09;

WHEREAS, post-qualification was conducted on 19 & 20 November 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Great Swiss Metal Builders Corporation and in the Post-Qualification Report, as approved by the BAC on 02 December 2021, Great Swiss Metal Builders Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **GREAT SWISS METAL BUILDERS CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Puerto Galera Port Expansion Project, Port of Puerto Galera, Oriental Mindoro, in the amount of **ONE HUNDRED FORTY SEVEN MILLION SIX HUNDRED TWENTY THREE THOUSAND EIGHT HUNDRED EIGHTY FIVE PESOS AND 09/100(₱ 147,623,885.09)**, inclusive of taxes, to the said bidder.
