WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Binoculars, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 11 November 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 5,000,000.00;

WHEREAS, in response to the said advertisement, only Golden Success Trading and Construction secured the Bid Documents and submitted the Technical and Financial Proposals;

WHEREAS, during the opening of bids on 02 December 2020 at 10:00 a.m., Golden Success Trading and Construction was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Golden Success Trading and Construction was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS Golden Success Trading and Construction was declared as the Single Calculated Bidder in the amount of ₱ 5,000,000.00;

WHEREAS, post-qualification was conducted on 10 December 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Golden Success Trading and Construction and in the Post-Qualification Report, as approved by the BAC on 14 December 2020, Golden Success Trading and Construction was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **GOLDEN SUCCESS TRADING AND CONSTRUCTION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply and Delivery of Binoculars, in the amount of **FIVE MILLION PESOS (₱ 5,000,000.00)**, inclusive of taxes, to the said bidder.
