Award of Contract for the

RESTORATION OF ROCKBULKHEAD, PASSENGER TERMINAL BUILDING, TMO BUILDING AND PORT LIGHTING SYSTEM DUE TO TYPHOON KARDING AT PORT OF DINGALAN, AURORA

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Restoration of Rockbulkhead, Passenger Terminal Building, TMO Building and Port Lighting System due to Typhoon Karding at Port of Dingalan, Aurora, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 30 October 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 13,017,772.30**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of ₱ 25,000.00 and submitted their Technical and Financial Proposals, namely:

- 1. FPF Construction
- 2. E-Cube Total Source Corp.
- 3. A.I.M. Construction
- 4. Radiance Traders & Builders

WHEREAS, during the opening of bids on 22 November 2023 at 9:00 a.m., only FPF Construction was declared "passing" with the requirements of the First Envelope;

WHEREAS, A.I.M. Construction, E-Cube Total Source Corp. and Radiance Traders & Builders were declared "failed" with the requirements of the Technical Proposal, for the following reasons:

A.I.M. Construction:

- a. Failed to submit PRC License for the pledged Project Manager.
- b. Failed to submit proof of capacity for the pledged one (1) unit Concrete Vibrator, one (1) Electric Bar Bender, one (1) unit Electric Bar Cutter and one (1) unit Welding Machine.

E-Cube Total Source Corp.:

- a. Failed to submit the required form for the pledged key personnel.
- b. Failed to submit proof of ownership for the pledged one (1) unit Concrete Vibrator, one (1) unit oxygen/acetylene cutting outfit, one (1) unit Genset, one (1) unit Electric Bar Bender, one (1) unit Electric Bar Cutter and one (1) unit Electric Drill.

Radiance Traders & Builders:

- a. No contract completion date indicated in the Statement of Bidder's All On-going Government and Private Contracts, including contracts awarded but not yet started which is required under Section 6.1 of GPPB Resolution No. 16-2020.
- b. Failed to submit PRC License for the pledged Project Manager.
- c. Failed to submit proof of capacity for the pledged one (1) unit Concrete Vibrator, one (1) unit Electric Bar Bender, one (1) unit Electric Bar Cutter, one (1) unit Welding Machine and one (1) unit Genset.
- d. Failed to attach a copy of the Notice to Proceed as stated in the footnote of the bid form for the Statement of Bidder's All On-going Government and Private Contracts, including Contracts Awarded but not yet started.

WHEREAS, A.I.M. Construction, E-Cube Total Source Corp. and Radiance Traders & Builders signified their intentions not to file a request for reconsideration on their "failed" rating, hence, their Second Envelopes were returned unopened and duly received by their authorized representatives;

WHEREAS, the Financial Proposal of FPF Construction was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 24 November 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 28 November 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of FPF Construction;

WHEREAS, FPF Construction was declared as the Single Calculated Bidder in the amount of ₱ 12,940,369.63;

WHEREAS, post-qualification was conducted on 01 December 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by FPF Construction and in the Post-Qualification Report, as approved by the BAC on 05 December 2023, FPF Construction was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **FPF CONSTRUCTION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Restoration of Rockbulkhead, Passenger Terminal Building, TMO Building and Port Lighting System due to Typhoon Karding at Port of Dingalan, Aurora, in the amount of **TWELVE MILLION NINE HUNDRED FORTY THOUSAND THREE HUNDRED SIXTY NINE PESOS AND 63/100 (12,940,369.63)**, inclusive of taxes, to the said bidder.
