### **RESOLUTION DECLARING FAILURE OF BIDDING FOR THE CONSTRUCTION OF PORT OPERATIONS BUILDING, PLATFORM WITH RORO RAMP AND RC PIER, PORT OF SAN ANDRES, CATANDUANES** LFP BCL No. 035-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Port Operations Building, Platform with RoRo Ramp and RC Pier, Port of San Andres, Catanduanes, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 14 November 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be bid as posted/advertised is **₱ 159,277,347.35**;

WHEREAS, in response to the said advertisement, only Northern Builders secured the Bid Documents;

WHEREAS, Northern Builders did not submit their bid documents before the deadline for Submission of Bids at 9:00 a.m. on 10 December 2019 nor did they submit a letter of withdrawal from participating in the bidding before the deadline for submission of bids;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Construction of Port Operations Building, Platform with RoRo Ramp and RC Pier, Port of San Andres, Catanduanes, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Construction of Port Operations Building, Platform with RoRo Ramp and RC Pier, Port of San Andres, Catanduanes, be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.

2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
