RESOLUTION DECLARING THE POST-DISQUALIFICATION OF ORIENTECH CONSTRUCTION & DEVELOPMENT CORPORATION FOR THE RESTORATION/IMPROVEMENT OF COLLAPSED PAVEMENT INCLUDING RC PLATFORM, PORT OF AMBULONG, SIBUYAN, ROMBLON HO-INFRA-PPDD-23-0061

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Restoration/Improvement of Collapsed Pavement including RC Platform, Port of Ambulong, Sibuyan, Romblon, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 03 November 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 20,569,262.32**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of \$\mathbb{P}\$25,000.00 and submitted their Technical and Financial Proposals, namely;

- 1. Mancol Construction Corporation
- 2. Orientech Construction & Development Corporation

WHEREAS, during the opening of bids on 28 November 2023 at 9:00 a.m., the two (2) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 04 December 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 05 December 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Orientech Construction & Development Corporation and Mancol Construction Corporation, as follows:

WHEREAS, Orientech Construction & Development Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 20,347,911.35;

WHEREAS, post-qualification was conducted on 06 to 08 December 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Orientech Construction & Development Corporation and in the Post-Qualification Report, as approved by the BAC on 12 December 2023, Orientech Construction & Development Corporation was declared post-disqualified, for the following grounds:

- No capacity was indicated in the specification plate attached to the pledged one (1) unit Air Compressor (250 cfm, min.), one (1) unit Payloader (93 hp, 1.06 cu.m), one (1) unit Road Grader (125 hp, min.) and one (1) unit Truck Mounted Crane (35T). The Air Compressor presented is under capacity and different from what was required. Based on online verification, the actual equipment models presented of the Payloader-Hitachi LX50-7 (59 hp, 0.9 cu.m.), Road Grader-Komatsu GD31 (110hp) and Truck Mounted Crane-Kato NK200H (20T) are under capacity.
- 2. Failed to present the original supporting documents (i.e. receipts, deed of sale) for the pledged one (1) unit Bar Bender, one (1) unit Clamshell, one (1) unit Concrete Cutter, one (1) unit Payloader, one (1) unit Road Grader and one (1) unit Truck Mounted Crane. What were presented are scanned print documents.
- 3. Failed to present the actual equipment for the pledged two (2) units Bar Bender, one (1) unit Bar Cutter, one (1) unit Clamshell, one (1) unit Road Roller and one (1) unit Water Truck Wagon;
- 4. Failed to present the pledged one (1) unit Welding Machine (400-amp). What was presented was one (1) unit Welding Machine (300-amp) which is under capacity.

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED as follows:

- 1. To declare ORIENTECH CONSTRUCTION & DEVELOPMENT CORPORATION as post-disqualified.
- To immediately notify ORIENTECH CONSTRUCTION & DEVELOPMENT CORPORATION in writing of its post-disqualification and the grounds for it.
- 3. To initiate and complete the post-qualification process on the second lowest calculated bidder, **MANCOL CONSTRUCTION CORPORATION**, pursuant to Section 34.6 of the 2016 Revised IRR of R.A. 9184.

AMBULONG, SIBUYAN, ROMBLON

This has reference to the Opening of Bids for the Restoration/Improvement of Collapsed Pavement Including RC Platform, Port of Ambulong, Sibuyan, Romblon, held on 28 November at 9:00 a.m., where the Lowest Calculated Bidder, Orientech Construction & Development Corporation was declared post-disqualified for the following reasons:

1. No capacity was indicated in the specification plate attached to the pledged one (1) unit Air Compressor (250 cfm, min.), one (1) unit payloader (93 hp, 1.06 cu. m.), one (1) unit Road Grader (125 hp, min) and one (1) unit Truck mounted crane (35t). The Air Compressor presented is under capacity and different from what was required. Based on online verification, the actual equipment models presented of the Payloader-Hitachi LX50-7 (59 hp. 0.9 cu. m.), Road Grader-Komatsu GD31 (110hp) and Truck mounted Crane-Kato NK200H (20t) are under capacity.

2. Failed to present the original supporting documents (i.e. Receipts, deed of sale) for the pledged one (1) unit Bar Bender, one (1) unit clamshell, one (1) unit concrete cutter, one (1) unit payloader, one (1) unit road grader and one (1) unit truck mounted crane. What were presented are scanned print documents.

3. Failed to present the actual equipment for the pledged two (2) units bar bender, one (1) unit bar cutter, one (1) unit clamshell, one (1) unit road roller and one (1) unit water truck wagon.

4. Failed to present the pledged one (1) unit welding machine (400amp). What was presented was one (1) unit welding machine (300 amp), which is under capacity.

In view thereof, we are submitting herewith BAC Resolution No. 0058-2023, Series of 2023, Declaring the Post-Disqualification of Orientech Construction & Development Corporation and to initiate and complete the post-qualification process on the second lowest calculated bidder, MANCOL CONSTRUCTION CORPORATION, pursuant to Section 34.6 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
