WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of General Support Services for PPA Port Management Offices (PMOs) – Luzon Cluster, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 11 November 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 69,867,427.30**;

WHEREAS, in response to the said advertisement, only DBP Service Corporation secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 04 December 2019 at 10:00 a.m., DBP Service Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of DBP Service Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 10 December 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 11 December 2019, showed discrepancies between the Total Bid Prices and Unit Bid Prices of DBP Service Corporation;

WHEREAS, DBP Service Corporation was declared as the Single Calculated Bidder in the amount of **₱ 69,618,750.72**;

WHEREAS, post-qualification was conducted on 16 December 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by DBP Service Corporation and in the Post-Qualification Report, as approved by the BAC on 18 December 2019, DBP Service Corporation was declared as the Single Calculated and Responsive Bidder;


NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **DBP SERVICE CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of General Support Services for PPA Port Management Offices (PMOs) – Luzon Cluster, in the amount of **SIXTY NINE MILLION SIX HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED FIFTY AND 72/100 PESOS** (₱ 69,618,750.72), inclusive of taxes, to the said bidder.
