WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of General Support Services for PPA Port Management Offices (PMOs) - Mindanao Cluster, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 11 November 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 60,963,423.84**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of ₱ 50,000.00, namely:

1. DBP Service Corporation
2. LSERV Corporation

WHEREAS, during the opening of bids on 09 December 2019 at 10:00 a.m., the two (2) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

2. LSERV CORPORATION	₱ 58,039,375.80

WHEREAS, Bid Evaluation was conducted on 10 December 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 11 December 2019, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of the two (2) bidders;

WHEREAS, DBP Service Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 56,002,864.68;

WHEREAS, post-qualification was conducted on 16 December 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by DBP Service Corporation and in the Post-Qualification Report, as approved by the BAC on 18 December 2019, DBP Service Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **DBP SERVICE CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Procurement of General Support Services for PPA Port Management Offices (PMOs) - Mindanao Cluster, in the amount of **FIFTY SIX MILLION TWO THOUSAND EIGHT HUNDRED SIXTY FOUR AND 68/100 PESOS (₱ 56,002,864.68)**, inclusive of taxes, to the said bidder.
