Award of Contract for the
**JORDAN PORT EXPANSION PROJECT, PORT OF JORDAN,
BRGY. HOSKYN, JORDAN, GUIMARAS**
HO-INFRA-PPDD-23-0024

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Jordan Port Expansion Project, Port of Jordan, Brgy. Hoskyn, Jordan, Guimaras, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 11 November 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 360,801,962.62**;

WHEREAS, in response to the said advertisement, nine (9) bidders secured the Bid Documents in the amount of **₱ 50,000.00**, namely:

1. WTG Construction and Development Corporation
2. Khan Kon Chi Construction and Development Corporation
3. Hi-Tone Construction and Development Corporation
4. Luzviminda Engineering
5. MAC Builders
6. MRBII Construction Corporation
7. Sunwest, Inc.
8. F. Gurra Construction, Inc.
9. IBC International Builders Corporation

WHEREAS, only eight (8) bidders dropped their Technical and Financial Proposals before the deadline for the submission of bid documents on 05 December 2023. IBC International Builders Corporation submitted its letter of withdrawal from participating in the bidding, dated 04 December 2023, before the prescribed deadline for submission thereof, and the BAC, finding the reasons to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 05 December 2023 at 2:00 p.m., only seven (7) bidders were declared “passing” with the requirements of the First Envelope, namely: WTG Construction and Development Corporation, Khan Kon Chi Construction and Development Corporation, Hi-Tone Construction and Development Corporation, Luzviminda Engineering, MAC Builders, MRBII Construction Corporation and Sunwest, Inc.. F. Gurrea Construction, Inc. was declared “failed” for failure to meet the required experience record for the Rock Works, the requirement is 50-2000 kg/pc. What was submitted was 50-1000 kg/pc;

WHEREAS, F. Gurrea Construction, Inc. signified no intention to file their request for reconsideration on their “failed” rating, hence, their Second Envelope was returned unopened and duly received by their authorized representative;

WHEREAS, the Financial Proposals of the seven (7) bidders were opened and declared “passing” with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 11 December 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 13 December 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Sunwest, Inc., WTG Construction and Development Corp., Luzviminda Engineering and Hi-Tone Construction and Development Corp., as follows;

WHEREAS, MRBII Construction Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 359,299,721.32;

WHEREAS, post-qualification was conducted on 15 December 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by MRBII Construction Corporation and in the Post-Qualification Report, as approved by the BAC on 18 December 2023, MRBII Construction Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **MRBII CONSTRUCTION CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Jordan Port Expansion Project, Port of Jordan, Brgy. Hoskyn, Jordan, Guimaras, in the amount of **THREE HUNDRED FIFTY NINE MILLION TWO HUNDRED NINETY NINE THOUSAND SEVEN HUNDRED TWENTY ONE PESOS AND 32/100 (₱ 359,299,721.32)**, inclusive of taxes, to the said bidder.
