Award of Contract for the
**SALOMAGUE PORT EXPANSION PROJECT, PORT OF SALOMAGUE,
BRGY. SALOMAGUE, CABUGAO, ILOCOS SUR**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Salomague Port Expansion Project, Port of Salomague, Brgy. Salomague, Cabugao, Ilocos Sur, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 27 July 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 428,117,962.04**;

WHEREAS, in response to the said advertisement, ten (10) bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

1. WTG Construction and Development Corporation
2. Hi-Tone Construction and Development Corporation
3. Luzviminda Engineering
4. Goldridge Construction and Development Corporation
5. MAC Builders
6. MRBII Construction Corporation
7. Vicente T. Lao Construction
8. UKC Builders, Inc.
9. Sunwest, Inc.
10. Sta. Clara International Corporation

WHEREAS, only nine (9) bidders dropped their Technical and Financial Proposals before the deadline for the submission of bid documents on 05 December 2023. Sta. Clara International Corporation submitted its letter of withdrawal from participating in the bidding, dated 05 December 2023, after the prescribed deadline for submission thereof, hence was considered as non-submission of bids, pursuant to Section 26.2 of the 2016 Revised IRR of R.A. 9184;

WHEREAS, during the opening of bids on 05 December 2023 at 9:00 a.m., the nine (9) bidders were declared “passing” with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the nine (9) bidders were opened and declared “passing” with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 11 December 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 13 December 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Sunwest, Inc., Luzviminda Engineering, WTG Construction and Development Corp. and Hi-Tone Construction and Development Corp., as follows;

WHEREAS, post-qualification was conducted on 15 December 2023 to examine, validate and verify the eligibility, technical and financial requirements submitted by Goldridge Construction and Development Corporation and in the Post-Qualification Report, as approved by the BAC on 18 December 2023, Goldridge Construction and Development Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **GOLDRIDGE CONSTRUCTION AND DEVELOPMENT CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Salomague Port Expansion Project, Port of Salomague, Brgy. Salomague, Cabugao, Ilocos Sur, in the amount of **FOUR HUNDRED TWENTY SIX MILLION ONE HUNDRED EIGHTY THOUSAND SEVEN HUNDRED EIGHT PESOS (₱ 426,180,708.00)**, inclusive of taxes, to the said bidder.
