RESOLUTION DECLARING FAILURE OF BIDDING FOR THE IMPROVEMENT OF ADMIN BUILDING, PORT OF BATANGAS, BATANGAS CITY HO-INFRA-PPDD-23-0064

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Improvement of Admin Building, Port of Batangas, Batangas City, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 24 November 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 12,061,975.78**;

WHEREAS, no bidder responded and secured the bid documents for the said project;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Improvement of Admin Building, Port of Batangas, Batangas City, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

“35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Improvement of Admin Building, Port of Batangas, Batangas City, be declared a “failure” pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184 considering that no bids are received.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
