WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P** 106,125,456.00;

WHEREAS, in response to the said advertisement, only Sagittarius Security Agency secured and submitted the Bid Documents;

WHEREAS, during the opening of bids on 09 December 2019 at 2:00 p.m., Sagittarius Security Agency was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Sagittarius Security Agency was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:
