RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF ORIGINAL BRANDED INK TONERS BAC-PGCS-135-2020

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Original Branded Ink Toners, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 26 November 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 2,400,000.00;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of ₱ 5,000.00, namely:

1. Microgold Information Solution and Products, Inc.
2. T and E Enterprises
3. Dalaz Enterprises

WHEREAS, only T and E Enterprises dropped its Technical and Financial Proposals in the bid box before the deadline prescribed for submission of bid documents. Dalaz Enterprises did not submit their bid documents nor submitted a letter of withdrawal from participating in the bidding before the prescribed deadline for submission of bid documents, while Microgold Information Solution and Products, Inc. was late in the submission of their Technical and Financial Proposals, hence the same were not accepted by the BAC Secretariat;

WHEREAS, during the opening of bids on 17 December 2020 at 3:00 p.m., T and E Enterprises was automatically disqualified for submitting its Technical Proposal with soft cover, in violation of the bid submission required under Clause 15 of the Bid Data Sheet of the Bidding Documents, which states that "xxx All bid documents shall be book bound, hard bound and properly labelled with index tabs";

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:


1. To recommend to the Head of the Procuring Entity that the bidding for the Supply and Delivery of Original Branded Ink Toners, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Bidding for the Supply and Delivery of Original Branded Ink Toners held on 17 December 2020, which was declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: b) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC-PGCS Resolution No. 132-2020 Series of 2020, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
