Award of Contract for the CONSTRUCTION OF GATE COMPLEX, PORT OF CAGAYAN DE ORO, MISAMIS ORIENTAL

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Gate Complex, Port of Cagayan de Oro, Misamis Oriental, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 29 September 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 55,144,384.64**;

WHEREAS, in response to the said advertisement, only Jejor's Construction Corporation secured the Bid Documents in the amount of \$\mathbb{P}\$ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 20 October 2021 at 10:00 a.m., the lone bidder was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Jejor's Construction Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 27 October 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 28 October 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Jejor's Construction Corporation;

WHEREAS, Jejor's Construction Corporation was declared as the Single Calculated Bidder in the amount of \$\mathbb{P}\$ 54,761,684.64;

WHEREAS, post-qualification was conducted on 05 & 09 November 2021 to examine, validate, and verify the eligibility, technical and financial requirements submitted by Jejor's Construction Corporation and in the Post-Qualification Report, as approved by the BAC on 10 November 2021, Jejor's Construction Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare JEJOR'S CONSTRUCTION **CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Gate Complex, Port of Cagayan de Oro, Misamis Oriental, in the amount of FIFTY FOUR MILLION SEVEN HUNDRED SIXTY ONE THOUSAND SIX HUNDRED EIGHTY FOUR PESOS AND 64/100 (₱ 54,761,684.64), inclusive of taxes, to the said bidder.
