WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement for the Development of Facial Recognition for Contactless Attendance Tracking with Mobile and Evacuation Application and Visitor Management System, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 18 October 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 118,000,000.00**;

WHEREAS, in response to the said advertisement, only Cosmotech Philippines, Inc. secured the Bid Document in the amount of ₱ 50,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 09 November 2021 at 10:00 a.m., Cosmotech Philippines, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Cosmotech Philippines, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 15 November 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 16 November 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Cosmotech Philippines, Inc. ;

WHEREAS, Cosmotech Philippines, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 117,989,000.00;

WHEREAS, post-qualification was conducted on 19 November 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Cosmotech Philippines, Inc. and in the Post-Qualification Report, as approved by the BAC on 23 November 2021, Cosmotech Philippines, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **COSMOTECH PHILIPPINES, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Procurement for the Development of Facial Recognition for Contactless Attendance Tracking with Mobile and Evacuation Application and Visitor Management System, in the amount of **ONE HUNDRED SEVENTEEN MILLION NINE HUNDRED EIGHTY NINE THOUSAND PESOS (PHP 117,989,000.00)**, inclusive of taxes, to the said bidder.
