Award of Contract for the
**CONSTRUCTION OF BREAKWATER, PORT OF ABRA DE ILOG,
OCCIDENTAL MINDORO**
LFP MDO NO. 030-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Breakwater, Port of Abra de Ilog, Occidental Mindoro, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 29 September 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 529,905,132.08**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of ₱ 75,000.00 and submitted their Technical and Financial Proposals, namely:

1. Goldridge Construction and Development Corporation
2. Sunwest Construction and Development Corporation
3. MAC Builders
4. Kwan Sing Construction Corporation

WHEREAS, during the opening of bids on 20 October 2021 at 2:00 p.m., only three (3) bidders were declared "passing" with the requirements of the First Envelope. Kwan Sing Construction Corporation was declared "failed" for failure to comply with the requirements of the First Envelope (Technical Component);

WHEREAS, Kwan Sing Construction Corporation signified its intention to file a request for reconsideration, hence, its Second Envelope was retained by the BAC until the request for reconsideration is resolved;

WHEREAS, the Financial Proposals of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Kwan Sing Construction Corporation notified the BAC thru an e-mail dated 25 October 2021, that they will no longer file a motion for reconsideration;

WHEREAS, Bid Evaluation was conducted on 27 October 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 28 October 2021, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Sunwest Construction and Development Corporation;

WHEREAS, Goldridge Construction and Development Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 525,888,678.00;

WHEREAS, post-qualification was conducted on 03 & 04 November 2021 to examine, validate, and verify the eligibility, technical and financial requirements submitted by Goldridge Construction and Development Corporation and in the Post-Qualification Report, as approved by the BAC on 10 November 2021, Goldridge Construction and Development Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **GOLDRIDGE CONSTRUCTION AND DEVELOPMENT CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Breakwater, Port of Abra de Ilog, Occidental Mindoro, in the amount of **FIVE HUNDRED TWENTY FIVE MILLION EIGHT HUNDRED EIGHTY EIGHT THOUSAND SIX HUNDRED SEVENTY EIGHT PESOS (₱ 525,888,678.00)**, inclusive of taxes, to the said bidder.
