



**BAC RESOLUTION OF AWARD**  
Resolution No. BAC-NCR SOUTH-14-19  
Series of 2019

WHEREAS, the PMO-NCR South Bids and Awards Committee (BAC) convened on 13 Nov. 2019, 2:00 P.M. at the PMO-NCR South Conference Room, South Harbor, Port Area, Manila to conduct a Public Bidding as mandated by the Implementing Rules and Regulations (IRR-A) of RA 9184 for the project ***"Provision of septic tank for 3<sup>rd</sup> to 5<sup>th</sup> floor use of PMO NCR South, Marsman Bldg. premises, MDSF, South Harbor, Port Area, Manila"***(PMONCR-SOUTH-A190001);

WHEREAS, on the same date November 13, 2019, only one (1) Contractor **RCE GLOBAL CONSTRUCTION INC.** submitted its bid proposal and found to have complied with the requirements and was rated and declared "passed".

WHEREAS, after the detailed evaluation of bids, the Bids and Awards Committee (BAC) declared **RCE GLOBAL CONSTRUCTION INC.** with its bid price of ***Four Hundred Sixteen Thousand Two Hundred Thirty Eight and 37/100 Pesos (P416,238.37)*** as the Single Calculated Bidder (SCB);

WHEREAS, upon post-qualification and after careful examination, validation and verification of all the technical and financial requirements submitted to the BAC by the bidder with the Single Calculated Bid (SCB), the bidder, **RCE GLOBAL CONSTRUCTION INC.** passed the required post-qualification, and therefore, was determined as the Single Calculated Responsive Bidder (SCRB) considered for award of the contract.

NOW, THEREFORE, We, the Member of the Bids and Awards Committee (BAC), hereby **RESOLVED** as it is hereby **RESOLVED**:

- a. To declare **RCE GLOBAL CONSTRUCTION INC.** as the Bidder with the Single Calculated Responsive Bid (SCRB) for the project **PROVISION OF SEPTIC TANK FOR 3<sup>RD</sup> TO 5<sup>TH</sup> FLOOR USE OF PMO NCR SOUTH MARSMAN BLDG. PREMISES, MDSF, SOUTH HARBOR, PORT AREA, MANILA.**
- b. To award the Contract to **RCE GLOBAL CONSTRUCTION INC.** as the bidder with the Single Calculated Responsive Bidder (SCRB) in the amount of **FOUR HUNDRED SIXTEEN THOUSAND TWO HUNDRED THIRTY EIGHT AND 37/100 PESOS (P 416,238.37)**, subject to existing rules and regulations.
