Declaring as Failure the Bidding of the Busuanga Port Development Project, Port of Busuanga, Busuanga, Palawan

WHEREAS, the Philippine Ports Authority PMO-Palawan advertised the Re-Invitation to Bid for the Busuanga Port Development Project, Port of Busuanga, Busuanga, Palawan in the Manila Times on May 8, 2017 and posted the same in the Phil-GEPS and PPA websites and at the bulletin board of PMO-Palawan continuously for seven (7) days from May 8-14, 2017;

WHEREAS, there were no prospective bidders/contractors who purchased bid documents until the published deadline of submission of bid/s on May 29, 2017 at 8:30 A.M.;

NOW THEREFORE, for and in consideration of the foregoing premises, the PMO-Palawan Bids and Awards Committee hereby resolves, as it hereby resolves, to declare the Bidding of the Busuanga Port Development Project, Port of Busuanga, Busuanga, Palawan as a FAILURE;

RESOLVED FURTHER, to recommend to the Acting Port Manager of PMO-Palawan, the head of the procuring entity, to inform the Assistant General Manager for Engineering regarding the three (3) failure of bidding conducted by the PMO-Palawan Bids and Awards Committee and to respectfully inform Department of Transportation (DOTr) for its appropriate action and consideration the result of the procurement process, as provided for under RA 9184 and its 2016 revised IRR.


