Declaring the Bid of ORIENT STAR CONSTRUCTION, INC. as the Single Calculated Responsive Bid for the project NCP-PLW-01-2017 Installation of Solar Power Port Lighting System, Port of Puerto Princesa, Palawan and Recommending Approval Thereof and Recommending Award of Contract

WHEREAS, the Philippine Ports Authority- Port Management Office of Palawan advertised/posted the Invitation to Bid for the project NCP-PLW-01-2017 Installation of Solar Power Port Lighting System, Port of Puerto Princesa, Palawan in the PhilGEPS and PPA websites and at the bulletin board of PMO-Palawan continuously for seven days from May 12 to 18, 2017;

WHEREAS, in response to said advertisement, two (2) prospective bidders purchased bidding documents, namely:

- 1.) EQUATOR ENERGY CORPORATION
- 2.) ORIENT STAR CONSTRUCTION, INC.

WHEREAS, both the contractors/bidders submitted their bids in sealed envelope within published deadline;

WHEREAS, at 9:57 A.M. on May 31, 2017, the Technical Bid of EQUATOR ENERGY CORPORATION was opened and declared ineligible/fail on the following:

Eligibility Requirements

- 1. No signatures of authorized signing official were affixed at the space provided for at the bottom of the Forms III, IV, V and VII as required in the Instruction for Eligibility Requirements Item III (a) to (c).
- 2. Non-conformance with the paging system as required in the Instruction for Eligibility Requirements Item VI (a).

Technical /Project Requirements

1. The Materials Engineer to be assigned to the contract has no attached Certificate of Accreditation from DPWH.

WHEREAS, during the meeting, Mr. Fabula, authorized managing officer of the EQUATOR ENERGY CORPORATION (EEC), signifies their intention to submit letter request for reconsideration regarding the above findings;

WHEREAS, at 11:20 A.M. on May 31, 2017, the Technical Bid of ORIENT STAR CONSTRUCTION, INC was opened and passed the preliminary examination. After which, the Financial Bids was opened and also passed the preliminary examination, and the result of its Financial Bid is tabulated as follows:
