RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROJECT MAINTENANCE OF VARIOUS PORT PHYSICAL FACILITIES, PORT OF CUYO, CUYO, PALAWAN (MPF-PLW-03-2023)

WHEREAS, the Philippine Ports Authority, PMO-Palawan posted an Invitation to Bid for the project MPF-PLW-03-2023 Maintenance of Various Port Physical Facilities, Port of Cuyo, Cuyo, Palawan, in the website of the PPA, PhilGEPS and in the Bulletin Board of PMO-Palawan on August 16-22, 2023, continuously for seven (7) calendar days.

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 891,063.31**.

WHEREAS, in response to the said advertisement/invitation, one (1) prospective bidder bought the Official Bid Documents at ₱1,000 each:

1. Orient Star Construction, Inc.

WHEREAS, the contractor/bidder submitted their bid in a sealed envelope within the published deadline;

WHEREAS, at 9:30 A.M. on September 5, 2023, the Technical bid of Orient Star Construction was opened and failed the preliminary examination.

WHEREAS, as per evaluation, it was determined that the bid of Orient Star Construction, Inc. was found to be ineligible and non-compliant with the requirements and conditions specified in the Bidding Documents;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the project MPF-PLW-03-2023 Maintenance of Various Port Physical Facilities, Port of Cuyo, Cuyo, Palawan, a failure, pursuant to Section 23 of the 2016 Revised IRR of R.A. 9184;

NOW THEREFORE, for and in consideration of the foregoing premises, the PMO-Palawan Bids and Awards Committee hereby RESOLVE as it is hereby RESOLVED to recommend the following:

 To recommend to the Head of the Procuring Entity that the bidding for the project MPF-PLW-03-2023 Maintenance of Various Port Physical Facilities, Port of Cuyo, Cuyo, Palawan, be declared a "failure" pursuant to Section 23 of the 2016 Revised IRR of R.A. 9184.
